

Construction Induction - White Card Course

ICG Training and Consultancy Services Pty Ltd's Construction Induction Course is designed to provide essential work health and safety (WHS) training for individuals preparing to undertake construction work. This mandatory training ensures participants understand and can demonstrate awareness and knowledge of health and safety legislative requirements, which is critical for preventing injury and harm in the construction environment.



The Construction Induction – White Card Course covers the mandatory requirements for working in a construction site. The program covers foundational information relating to Work Health and Safety requirements to prevent injury and harm in a work environment.

From the guidance of our highly skilled and experienced trainers, you will learn how to:

- Identify and report common construction hazards.
- Understand and implement basic risk control measures.
- Identify procedures for responding to potential incidents and emergencies.
- Select and correctly fit common personal protective equipment (PPE) used in construction work.

Delivery Mode

This course is delivered face-to-face in a classroom setting with theoretical knowledge and practical training and assessment activities in a simulated work environment.

Assessment Methods

- Theory-based questioning
- Demonstration of practical skills
- Verbal reporting and documentation completion

Target Cohort

This course targets new entrants to the mining, energy and resources, utilities, power generation, renewable energy, civil construction, and earth moving sectors who are required to work on a construction site and/or workers needing to update their safety knowledge, and organisations seeking to ensure their staff are adequately prepared to work safely in construction environments.

Students must:

- Have an orientation towards working in an industry related to construction work.
- Be at least 14 years old at the time of completion.
- Be located in Tasmania.

How to Obtain your White Card

To obtain a white card in Tasmania, participants who successfully complete this training must apply to [Service Tasmania](#) within 60 days by:

- Completing the [Construction Induction Card Application Form](#)
- Taking the application form, their Statement of Attainment issued by ICG, and describing the CPCWHS1001 unit of competency, as well as the identify documents to a [Service Tasmania](#) outlet
- Paying the applicable fee

At the time of lodgement, the participant's details and identification will be checked and the fee accepted. Their application will then be forwarded to WorkSafe Tasmania for processing and the card will be sent to the applicants nominated address.
